RESOLVED

The Council of Blue Crane Route Municipality, acting in terms of section 16 of the Municipal Finance Management Act, (Act 56 of 2003) take note of the contents of the following budget tables as prepared according to the mSCOA version 6.9:

- 1.1.1 The draft annual budget of the municipality for the financial year 2025/2026 and the multi-year and single-year capital appropriations as set out in the following tables:
- 1.1.2 Budgeted Financial Performance (revenue and expenditure by standard classification) as contained in BCRM Table A2;
- 1.1.3 Budgeted Financial Performance (revenue and expenditure by municipal vote) as contained in BCRM Table A3;
- 1.1.4 Budgeted Financial Performance (revenue by source and expenditure by type) as contained in BCRM Table A4; and
- 1.1.5 Multi-year and single-year capital appropriations by municipal vote and standard classification and associated funding by source as contained in BCRM Table A5.

The financial position, cash flow budget, cash-backed reserve/accumulated surplus, asset management and basic service delivery targets are noted as set out in the following tables:

- 1.5 That Council take note of the recommended tariff structure percentage increases, as follows:
 - Rates 10%
 - Water, Sewer/Sanitation and Refuse removal services 6%
 - Electricity 12.74% depending on NERSA's tariff guideline and approval
- 1.6 That Council takes note that a salary increases of 5.3% is included in the budget.
- 1.7 That Council take note that the budget related policies that are in place, the current status still the same and some still have to be reviewed and adopted before 31 March 2025.
- 1.8 That Council takes into account all comments, objectives and input that will be received after public and stakeholder consultations before the final adoption of the Final 2025/2026 IDP, the Final 2025/2026 SDBIP and Final 2025/2026 MTREF Budget documents by 31 May 2025.
