It is estimated that tenderers must have a CIDB contractor grading of 3CE or higher. In addition, only tenderers who comply with the following functionality criteria will be considered eligible:

Maximum possible score		100

Note - Any completed projects that are less than R500 000 (Incl. VAT) will not be allocated points.

Tender offers will only be considered responsive if a minimum Functionality Score of 60% is achieved.

This tender will be evaluated according to points awarded for price and B-BBEE Status Level of Contribution. The 80/20 Preference Point System will be applied to this tender.

Only tenderers who satisfy the eligibility criteria stated in the Tender Data will be considered eligible for an award.
