SPECIFICATION OF ORDER

BACKGROUND

The Cacadu District Development Agency (CDA) is a public sector, municipal owned and not-for-profit organization whose mandate is to facilitate socio-economic development in the Sarah Baartman District area with a clear vision of inclusive growth.

MINIMUM CIDB REQUIREMENTS

Grade 1 SK

SCOPE OF WORK

The Somerset East aerodrome is a small airport with a 1.2km runway. The aerodrome does have the original markings on its runway and taxiway and where visible the marks are fading. The work requirement is for re-painting of the lines to make them brighter (bold) with black, white, and yellow colours.

Service Providers are required to quote on the following:

- Marking of 1.2 km runway with one colour (white).
 - √ 8 rectangles 30m x 1.5m
 - √ 19 rectangles 30cm x 40m
- Marking of taxiway with two colours (yellow and black).
 - 5.4km x12cm Black
 - ✓ 2.7km x 15cm Yellow
 - √ 10 squares 2.55 square metre Yellow and 10 cm black line outside.

NB: It is required that only SACAA approved road marking paint be used.

TECHNICAL REQUIREMENTS FOR QUOTATIONS

- Company registration certificate (CK).
- CIDB certificate.
- Authority of signatory.
- Certified ID Copy (not older than 3 months).
- B-BBEE Status Level Certificate.

PROPOSED APPROACH AND DELIVERABLES

The proposal should describe the service providers proposed approach to the scope of work, as provided in the scope of work, including an implementation plan, layout and design, technical and operations management approach, linked to proposed timeframes.

PROJECT BUDGET AND PRICING

The CDA expects the bidders to observe the highest standards of ethics during the execution of this contract and reserves the right to terminate the contract at any stage if it is determined that these standards have been or may become compromised.

It should be noted that the agency will request verbal and / or written inputs on an ad hoc basis, as and when required, but it is envisaged that these inputs will be essential to an extent where implementation of project is finally completed.

All relevant information must accompany all quotations submitted. No late or incomplete quotation will be accepted for consideration.

The CDA reserves the right not to accept the lowest or any quotation and no reason to the acceptance or rejection of quotation will be furnished.

EVALUATION

Quotations will be evaluated in terms of the 80/20 preferential point system.

It should be noted that failing to attach the B-BBEE Status Level Certificate will result in the 20 preference points not being awarded.

TAX CLEARANCE CERTFICATE REQUIREMENTS

It is a condition of bid that the taxes of the successful bidder <u>must</u> be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the bidder's tax obligations.

PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2017

This preference form must form part of all bids invited. It contains general information and serves as a claim form for preference points for Broad-Based Black Economic Empowerment (B-BBEE) Status Level of Contribution

- 1.5 Failure on the part of a bidder to submit proof of B-BBEE Status level of contributor together with the bid, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.
- 1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

- "bid" means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;
